1. PNC Checking Account

Reconciling the church treasurer's report with the bank statements indicates the records are accurate.

Only 1 minor item on the treasurer's report was not found on the bank statement. On 9/15/2019 there are 2 entries on the treasurer's report for \$19.15. The bank statement had 1 entry for that amount dated 9/16/2019. Possibly it is a duplicate entry or was a transaction from the previous year.

2. PNC Brokerage Account

This account audit was limited. I compared the interest earned amounts, deposits and fund transfers on the treasurer's report with the activity amounts written on each month's PNC report. Amounts were identical.

3. Northwest Money Market Account

The bank's monthly interest payments are accurately listed in the deposit column of the treasurer's report. The 05/12 \$37 deposit has been removed by the treasurer. See attached email message. The treasurer's report end of month balances differ by small amounts with the Bank report figures. The 8/29 funds wired to Thomas Oduro were not recorded on the August bank statement.
